### Donor Advised Funds

We help businesses, individuals, and families set up a variety of funds to streamline and increase their generosity. One of these funds is called a Donor Advised Fund (DAF). Through a DAF, they can:

- Save time and simplify giving
- Unite gifts with others
- Turn tax dollars into ministry dollars
- Give through a personalized online portal



### Ministry Partner Program
