# WHAT WE DO

## Individual, Family, & Business Giving Funds

We help individuals, families, and businesses set up and strategically use Donor Advised Funds, also known as Giving Funds, to streamline and steward their generosity. Through these Giving Funds, they can:



### 01 Give cash and non-cash assets

Gifts such as personal property, appreciated stock and real estate, crops, and other non-cash assets can be given to support organizations in a tax-wise, streamlined manner.



### 02 Save time and simplify giving

Giving Fund holders can give to multiple organizations from one fund. This means they have just one tax receipt letter at the end of the year! Donors can also give anonymously to prevent their mailbox from filling with too much information.



### 03 Unite gifts with others

Giving Fund holders can leverage gifts with other fund holders to make an even greater impact toward important causes.



### 04 Turn tax dollars into ministry dollars

Giving Funds ensure more money goes to causes they believe in rather than taxes. Dollars can be directly transferred to a Giving Fund and not counted as income or capital gains! Therefore, donors don't have to pay taxes on the amount given and have more to give to the ministries they love.



We decided years ago that we wanted to be kingdom minded. When I heard about Ten Talents, it was just the perfect opportunity for us. We set up a Donor Advised Fund [also known as a Giving Fund, with Ten Talents].

## Ministry Partners

Our Ministry Partner Program equips nonprofits to fulfil their missions and remain healthy and effective through the responsible, creative, and strategic management of their resources. Through this program, we:



### Provide resources and training

We provide resources and training for Ministry Partners through workshops and materials to help them become more sustainable and use gifts most effectively. We also coach organizations on how to utilize a foundation like Ten Talents to grow!



### Help ministries accept cash & non-cash gifts

Ten Talents facilitates complex and creative giving, helping ministries accept and process cash and non-cash gifts like personal property, appreciated stock and real estate, crop/agricultural gifts, life insurance, annuities, and trusts.



### Connect ministries with one another

We encourage ministries to connect and collaborate with other like-minded individuals and organizations to pursue the collective goal of building God's kingdom.



### Create & manage Ministry Funds

Ten Talents has the ability to create a Ministry Fund, endowment, scholarship or "foundation" for organizations while eliminating the administration costs. We help the ministry focus on their mission.

**\$1,009,700** in grants were distributed to organizations through the Ten Talents Foundation in 2022!



## SINCE OUR 2020 LAUNCH, TEN TALENTS HAS:

Welcomed


**9 Founding Members**

Program & Operations: **\$103,000**


