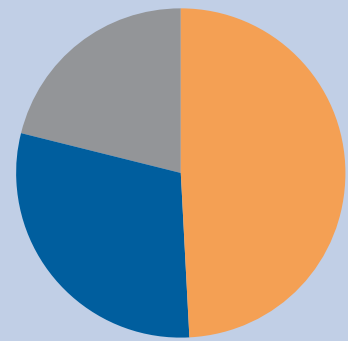
### Give Through an Impact Fund
